PCI Scanning Process –



Thank you all for your work in cleaning up the issues found during the scanning last quarter. We understand that the scanning process can be challenging and are very appreciative of your efforts in maintaining our compliance in this area.

Good News!

Zac Reimer is reviewing our current scanning procedures and believes we will be able to change how the scans run. Currently, the scanning is done internally through a scanning appliance housed at UNL. If we can change the scans to run from outside of the University, the number of vulnerabilities detected by the scans

should be reduced. This would ease the load placed on all of us by the PCI scans. We will follow up with you on any changes that will take place as Zac determines and implements any new procedures.

Future Quarterly Scan Schedule

Based on the last quarter's scan process, we have changed our schedule going forward. The "Official Quarterly PCI Scan" will be set for 3 wks prior to the end of the quarter. This will allow more time for any necessary documentation or system changes to be handled on any IPs that have FAILED.

The "Official 1st Quarter 2009-10

PCI Scan" is scheduled for: September 9th

Regularly Scheduled Scans

We will continue to do scans regularly throughout each quarter to allow new items that come up to be resolved quickly and as they occur. Hopefully, this will reduce the "crunch" felt when the official scan is run
